6-15-89 Perforate 9735-9856 with 4" csg guns, 2 JSPF @ 9735, 9752-57 (12), 9776-84 (18), and 9845-56 (22). Total 27 intervals, 54 holes. TIH with 5 1/2" RBP and packer on 2 7/8" w.s. Set RPB @ 9915'. Set pkr @ 9703'.
6-16-89 Acidized perms 9890-9910 with 1,000 gals. 15% NEFE, 55 gals TH-756 scale inhibitor, 55 gals Checkersol, and 30 b.s. Reset RBP and packer.
Acidized perms 9845-56 with 2,000 gals. gelled 15% NEFE acid containing 1 drum scale inhibitor and 35 b.s. Reset RBP and pkr.
Acidized perms 9735-84 with 2500 gals. gelled 15% NEFE with 1 drum scale inhibitor and 50 b.s. TOH with RBP and pkr.

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
