12-1-95 - TIH with 10-1/2" shoe with 10-7/8" rough OD cutrite, 4-3/4" Bowen jars and 14 4-3/4" drill collars. Tagged tight spot at 1035'. Rigged up swivel and reamed. Fell through tight spot at 1043'. Washed and reamed to 8-5/8" stub at 1043'. Continue washing and reaming to 1549'. Cut over 1-1/2'. Shoe wore out. TOOH. TIH with 10-1/2" OD slip joint on 8-5/8" 32# casing. Washed down last 7'. Landed on 8-5/8" stub. Nipped down BOP. Nipped up wellhead.
