Drilled 7-7/8" hole to 10,500 feet. Ran 5-1/2" 17# N-80 and J-55 short and long T&C casing to 10,500 feet. Circulated 1 hour and cemented with 250 sacks Incor Pozmix A. Cement with final pressure of 1700 psig. Cement job completed at 7:30 P.M., 12-24-67. Ran temperature survey which indicated top of cement outside of 5-1/2" casing at 10,000 feet. Removed blow-out preventers, installed tubing head and tested casing to 2000 psig. WOC time 72 hours. Ran bit and scraper on 2-7/8" tubing to top of cement plug at 10,430 feet. Displaced crude oil and pulled tubing out of hole. Perforated Wolfcamp formation 10,362 to 10,366' with 2 jets per foot. Set Model "D" packer on wire line at 10,325 feet and ran tubing. Swabbed well down to 9000 feet, acidized with 100 gallons 15% acid and swabbed well down and swab tested well 4 days. Acidized Wolfcamp perforations 10,362 to 10,366 feet with 500 gallons 15% acid, swabbed well for 9 hours with fluid level at 10,100 feet. Ran pump and rods, well on pump 1-19-68. Recovered all load oil and pumping new oil 1-24-68.
