Propose to squeeze cement and abandon Bough perfs 9958-76', drill out cement and recompleate in Devonian zone (salt water disposal).
 Pull tbg and pkr, re-run tbg (OE) to 10000: Spot 50 ax class H cmt w/3/10% LWL, 3% DA and 1/4# floccle per ax, raise tbg to 8000', pressure to 1000#, squeeze cement into Bough perfs.
 Pull tbg. Run tbg w/scraper, Test perfs 9958-76' to 1000#. Drill out cement to original TD of 12863'. Test old Devonian open hale 12816-863: Run plastic w/packer, complete for salt water disposal in Devonian zone.
