- Spudded well at 1:30 A. M. 2-22-69. A. W. Thompson, Inc. is the drilling contractor.
- Ran 13-3/8" 48# H-40 New casing to 366', cemented with 350 sacks regular cement. Plug down @ 3:15 P. M. 2-22-69. Cement did not circulate. Re-cemented around top of casing with 50 sacks cement.
- After WOC 24 hours, tested with 600 PSI for 30 minutes. Tested O. K.
- Drilled to 4105' T. D. Ran 8-5/8" O. D. 24# and 32# casing to 4105', cemented with 200 sacks with 4% Gel and 150 sacks with 2% Gel. Plug down 6:30 A. M. 3-1-69.
- WOC 24 hours, tested casing with 1000# for 30 minutes, O. K.
