Pumped 6000 gals 15% HCL and additives. Tagged RA material. Flushed with 42 bbls 2% KCL FW. Ran after treatment sur. Swabbed dry and No show of oil and no show of gas. Released packer and POH. RIH with bulldog Bailer and cleaned out to 9713' and POH. Rel RBP and pulled tbg and ran seating nipple LA 9725' and tbg anchor set at 9536'. MOSU 6-17-84 and pump tested apx. 19 days.
