Well drilled to a TD of 10,545. We propose to plug as follows:

Set 25 sacks plug over the parfs from 10,458 to 10,466. Will shoot off of 4 1/2" pipe @ approximately 6000'. Cement plugs as follows:
 25 sacks pipe on the stub of 4 1/2", 25 sacks @ Clozieta if stub is below 5000';
 25 sacks in and out of 8 5/8" @ 4340'. Cement plugs as follows: 25 sacks stub of 8 5/8" @ approximately 1200', 25 sacks in and out of surface 11 3/4" and 10 sacks @ surface.
