Plug back total depth is 10,354'. Filled hole with mud laden fluid.

- Spotted a 50 sack cement plug from 10,309' to 9836' on 8-26-75, lower Wolfcamp perms 10,309'-10,313'.
- Cut 5-1/2" casing at 4410'. Pulled and recovered all 5-1/2" csg above 4410' on 8-30-75.
- Spotted a 50 sack cement plug from 4434' to 4259', in and out of 5-1/2" casing stub, on 9-2-75.
- Shot 8-5/8" csg at 1247'. Pulled and recovered all 8-5/8" csg above shot point on 9-3-75.
- Spotted a 150 sack cement plug from 1312' to 1044', in and out of 8-5/8" casing stub, on 9-4-75.
- Spotted a 100 sack cement plug from 438' to 259', in and out of 11-3/4" casing shoe at 400', on 9-4-75.
- Placed a 10 sack cement plug from 22' to 4' below ground level, in 11-3/4" csg. Welded a steel plate on top of well head with dry hole marker extending 4' above ground level on 9-4-75.
