8- 1-72 T.D. 310'. W.O.C. Pressured up on 9-5/8" casing @ 500 lbs. for 30 minutes. No leaks. Drilling ahead.

8-13-72 T.D. 3123'. W.O.C. Ran 5-1/2", 14#, J-55 casing @ 3123' w/ 150 sx. Lite Wate and 125 sx. Class C + 5# NaCl per sx. W.O.C. 12 hrs. Kept pressure on 5-1/2" casing for 12 hours. No leaks.
