Drilled 17-1/2" hole to a depth of 363 feet. Ran 13-3/8" O.D., new, seamless, H-40, 48# casing to 363 feet (352 feet below ground level) and cemented with 375 sacks of Class C cement with 2% calcium chloride, on 3-24-77. Installed blow-out preventer. Let cement set for 24 hours. Drilled out cement to casing shoe. Pressured up casing to 800 psi for 30 minutes. Pressure held without decreasing. Resumed drilling at 9 PM on 3-25-77.
