RU Howco & cmt'd w/1400 sx Lite, 15# salt, 1/4# flocele, 5# gilsonite followed by 200 sx Class "C" w/2% CaCl. PD @ 9:45 PM 11/16/83. Bumped plug @ 1150 psi, press to 1350 psi, OK. Had good returns thru-out job. Circ'd, 200 sx cmt. WOC 12 hrs, ND, set slips, cut off csg. NU BOP's & tstd to 600 psi for 30 min. Reduced hole to 7-7/8" & cont'd drilling.
