T.D. 10770' Shale & Lime. Plugged and Abandoned. This well was plugged and abandoned in the following manner:

1. TIH w/open ended DP to 10592'. C&CH. Displaced a 75 sack Class H cement plug @ 10592 - 10367' (225'), across the top of the Cisco and Ranger Lake Formations.
2. Displaced a 75 sack Class H cement plug @ 10313 - 10088' (225'), across the top of the Bough B & Bough A Formations.
3. Displaced a 50 sack Class H cement plug @ 9414 - 9264' (150'), across the top of the Wolfcamp Formation.
4. Displaced a 50 sack Class H cement plug @ 7833 - 7683' (150'), across the top of the Abo Formation.
5. Displaced a 35 sack Class H cement plug @ 4330 - 4230' (100'), 1/2 in and 1/2 out of the 8-5/8" casing shoe @ 4300'. WOC 4 hrs. Tagged top of the plug @ 4450'. PU open ended DP to 4330' and displaced a 100 sack Class H w/2% CaCl₂ cement plug @ 4330 - 4450' (120'). WOC 4 hrs. Tagged top of plug @ 4300'.
6. Displaced a 35 sack Class H w/2% CaCl₂ cement plug @ 4051 - 3930' (121').
7. Displaced a 35 sack Class H cement plug @ 1800 - 1700' (100').
8. LDDP. ND BOP'S and CO wellhead. Spotted a 15 sack Class H cement surface plug @ 50 - 0'. Installed a 4" dry hole marker to designate a plugged and abandoned location.

This plugging procedure was given prior verbal approval by the MMS office @ Roswell, New Mexico and was also witnessed by their representative.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
