Ran and set 50 jts (2084.60') 8-5/8" OD 24# K-55 and 54 jts (2199.43') 8-5/8" OD 32# K-55 casing @ 4300' and cemented w/1800 sacks of TLW w/15# salt, 5# gilsonite & 0.25# celloflake/sack + 200 sacks of Class C w/3# salt/sack cement. PD @ 1745 MST on 12-25-83. Circulated 200 sacks of cement to pit. WOC 8 hrs. Tested 8-5/8" casing to 1000# for 30 min - OK.
