(335.40') 13-3/8" OD 54.5# K-55 and 1 Jt. (24.91') 13-3/8" OD 61# K-55 casing @ 379' and cemented w/400 sacks of Class C w/2% CaCl₂ & 1/4# cello-flake/sack cement. PD @ 0915 MST on 12-11-83. Cement circulated to surface. WOC 8 hrs. Tested 13-3/8" casing to 500# for 30 min - OK.
