Ran 10 joints 11-3/4" 42# H-40 ST&C casing (422') set at 418'. Insert float set at 380'. Cemented with 300 sxs Class C + 2% CaCl2 (yld 1.34, wt 14.8). PD at 7:48 AM. Bumped plug to 500 psi, held OK. Circ 63 sxs. WOC

7/9/01 - Drilled out at 3:00 AM. WOC 19 hours 10 mins.

Reduced hole to 11" and resumed drilling.
