FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

This well was drilled in 1953 and permission was granted to temporarily abandon the well on August 17, 1954. Operator now wishes to permanently abandon the well as follows: Shoot off 8 5/8" casing and recover. A 25 sack cement plug will be placed in and out of the bottom of the casing at 3,600', a similar plug in the stub of the casing and a similar plug in and out of the surface pipe at 260' and a 30' plug at the surface with a suitable 4 1/2" marker. According to where the pipe is shot off, it is the intention of the operator to isolate this salt section and protect fresh water in the area.
