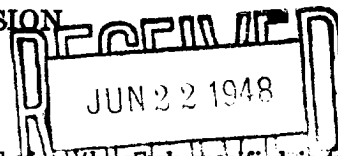

## FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Well No. 3, is located 150 feet west of Taylor No. 1, which was located in the center of the S4SW4 sec. 22. Location of well No. 3, is therefore located 1830 feet east of the west line of sec. 22, and 660 feet N of the S line of sec. 22, T2S, R30E, Roosevelt County, New Mexico.

It is proposed to run 6 5/8th., 29pd., casing at a depth of 1120 feet. Circulating 10 sacks of cement behind the pipe.
