**On October 11, 1966, we propose to set a 15-sack cement plug at 4125-3922', cut 4-1/2" casing off at 2510', set a 25-sack cement plug 2645-2439'; set a 25-sack cement plug at 1560-1442'; set a 25-sack plug at 401-305', and a 10-sack cement surface plug at 31-0'. All plugs will be set with tubing and the hole filled with 8.9# mud. Well site will then be conditioned for final inspection.**
