MANNER FOR PLUGGING WELL

August 6, 1967 Set 25 sacks cement from 4515'-4600', 25 sacks from 3235'-3320', 25 sacks from 2195'-2280', 25 sacks from 315'-400' and 10 sacks from 0'-30'. Plate welded on top of surface pipe with marker.
