Propose to drill a Montoya wildcat test using rotary tools to approximately 8200'. Cement will be circulated on the surface casing, intermediate will be set into the San Andres. Plan to test all significant shows and run BHC Acoustilog, GR-Caliper, focused dual induction log and Epithermal sidewall neutron logs at intermediate and total depth. Completion or abandonment will be performed in accordance with prudent practices and regulatory body requirements. Will use double ram 900 series BOP from surface casing to total depth.

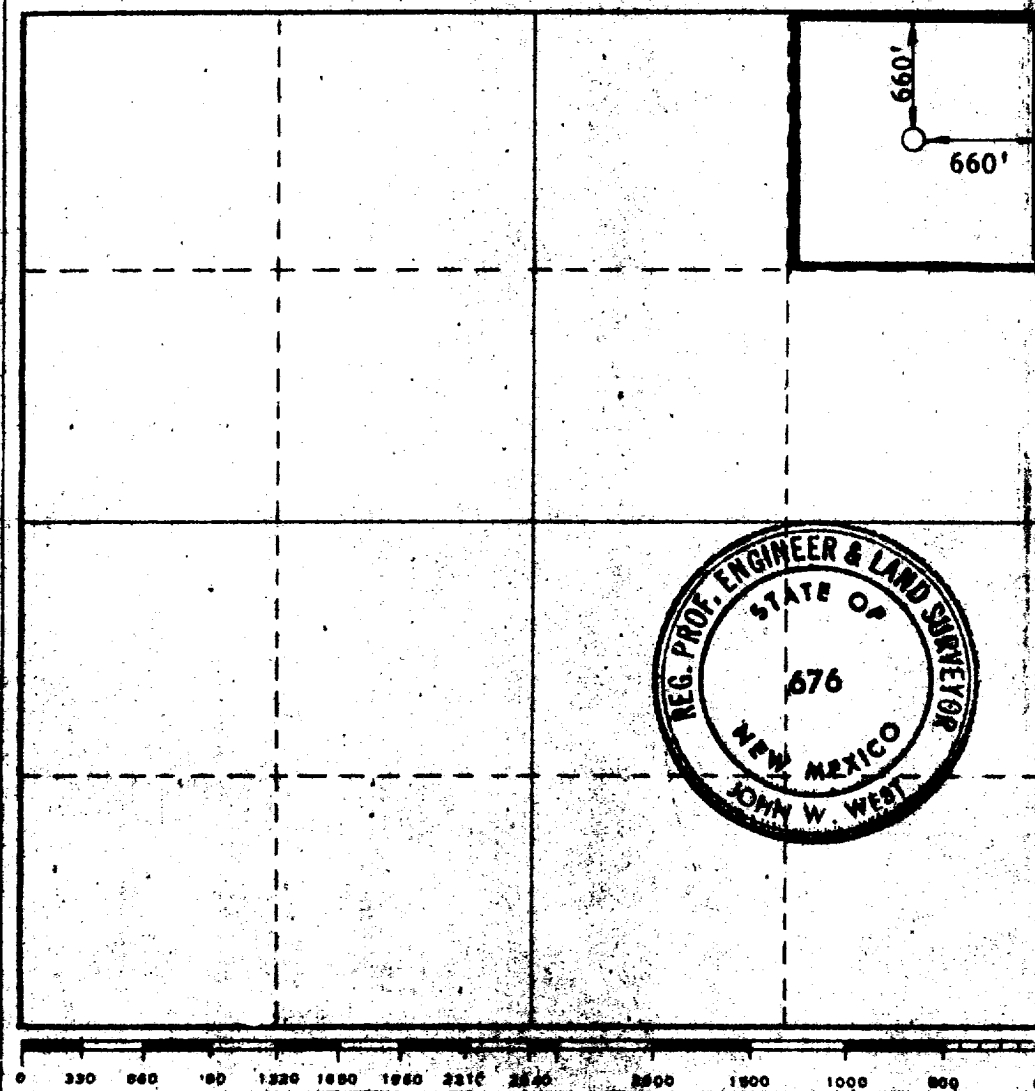
