Drilled a 17½" hole to 490'. Circulated 1 hour. Ran 10 jts. 12 3/4" 35# casing. Set casing @ 459' R.T. measurement. Cemented w/550 sx Class "C" 2% CaCl₂ w/¼# Flocele/sx. Circulated out 40 sx cement. Plug down @ 3 p.m. on 10/31/81. After 18 hours, nipped up B.O.P. & pressured to 700 psi for 30 minutes. Tested O.K. Commenced drilling.
