FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to plug and abandon subject well as follows:

1. Spot 20 Sx cement at total depth.
2. Cut off and recover 5½" O.D. casing. (Top of cement is at 7860')
3. Spot 30 Sx cement plug from 50' below to 50' above top of non-recoverable casing.
4. Spot 30 Sx plugs from 7400' to 7500', 6700' to 6800', 5400' to 5500', and over intermediate casing shoe from 3850' to 3950'.
5. Spot 20 Sx cement plug in surface, install 4" marker 4' above ground level as per NMOCC regulations, and clean location.
