Clean out hole to top of 8-5/8" casing stub at 1179 feet. Run 8-5/8" casing to top of 8-5/8" casing stub and connect with a casing bowl. Clean out hole to total depth - 10,050 feet. Run 4-1/2" J-55 and N-80 casing to 10,000 feet and cement with 300 sacks of cement. Perforate and treat the Bough B zone at approximately 9900 feet.
