Plan to set wire line bridge plug inside 5 1/2" casing at approximately 8450' ± and dump two sack cement plug on top with wire line.
Plan to pull and recover 5 1/2" casing from 8400' ±.
Plan to set 25 sack cement plug in and out of stub of 5 1/2" casing.
Plan to set 25 sack cement plug at top of Abo 7565' ±.
Plan to set 25 sack cement plug at top of Glorietta 5700' ±.
Plan to set 25 sack cement plug at bottom of 9 5/8" casing approximately 4164'.
Do not plan to attempt any recovery of 9 5/8" casing.
Plan to set 10 sack cement plug in top of 9 5/8" casing and erect marker.
Work will not start until written approval received.
