Backflow well to relieve pressure. MIRU. Clean out to 9800'. GIH w/2 7/8" work string and 7" BP and 7" pkr. Set BP at 9774', pkr at 9722'. Pump 2000 gals. 15% HCl-NE. Flush w/67 bbls. TFW. Unseat BP and pkr. Set BP at 9722', pkr at 9600'. Pump 2000 gals. 15% HCl-NE. Pump 500# diverting agent (rock salt dissolved in guar gum). Follow w/2000 gals. 15% HCl-NE. Flush w/67 bbls. TFW. Swab load back. Pool H w/tbg, BP, pkr. GIH w/PC 2 7/8" injection tbg. and injection pkr. Set pkr at 9264'. Place well back on injection.
