Locate hole on 5 1/2" csg. @ 5117'. Test casing above and
below hole w/1000#. O.K. Repeat tests by squeezing w/2000#. In
Clear "C" Cement w/ 3/4% oil and 5# sand per sack.
Squeeze pressure 3000#. Initial squeeze w/2000# for
30 min. O.K. Cement well back on production.
