Set 5 1/2" casing at 13,459', cemented with 1,190 sacks cement, using 48 centralizers and 248 scratchers. Plug down at 12:01 A.M. 9-30-54. Top cement outside 5 1/2" casing at 6,350'.

Tested casing with 1,000# pressure before drilling plug. No pressure drop. Drilled out cement plug to 13,457'. Tested casing with 1,000# pressure after drilling plug. No pressure drop.
