It is proposed to convert the subject well to injection in order to waterflood the 11210' reservoir.

1. Seal the well with Produced Water and Pull 2 1/2" ID, 10' down cut to 9600'
2. Run Tbg with treating flr set at $\pm$ 9650' and Pump 1000 Gals 15% acid. Flush with 30 bbls of Produced Water.
3. Pull back string of Tbg & Flr.
4. Run 2 1/2" Plastic coated tbg with outer Lock-set flr set AT $\pm$ 9650' and Hook up For Injection.
