150 Qt Solidified Glycerin Shot. Tamped with pea gravel. Shot did not clean hole and was necessary to clean out with cable tools after shot. Well swabbed through casing while cleaning out and, when swabbed, produced approximatel 3 barrels per hour. Official test after shot, for potential purposes being made yesterday and today.
