Perforated interval 3974-80 with 2 CJFF. Ran FENC and RFP and treated each zone individually with 250 gals MA with Keracene surfactant. Set injection packer at 3994', placed well on injection.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
