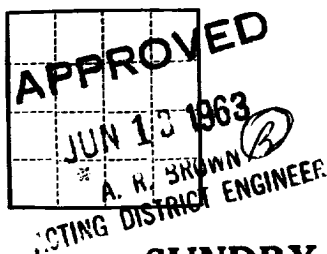

DETAILS OF WORK

In an effort to increase production it is proposed to perform remedial work by setting a retrievable bridge plug at approximately 10,010' and perforate intervals 9300'-20'; 9490'-9915'; and 9975'-95' with 2 BOPD. Acidize with 4,500 gallons, wash in and evaluate.
