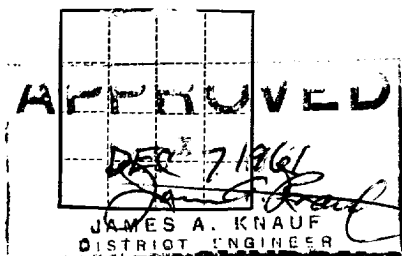

DETAILS OF WORK

It is our intention to drill a well at the above location to a total depth of approximately 4300'. All casing points will be cemented in accordance with approved methods of the U. S. G. S. and any other special requirements will be complied with.

It is planned to use the following casing pattern: 9 7/8" hole to be drld, 7 5/8" OD 24 1/2' S-40 Casing to be set at approximately 1050' and cemented with 450 sacks, cut to be circulated. 6 3/4" hole to be drld, 4 1/2" OD 9.50# J-55 casing to be set at approximately 4050' and cemented with 200 sacks. It is calculated the cement behind the 4 1/2" casing will return to 2050'

Approval to produce this well upon completion is also requested.

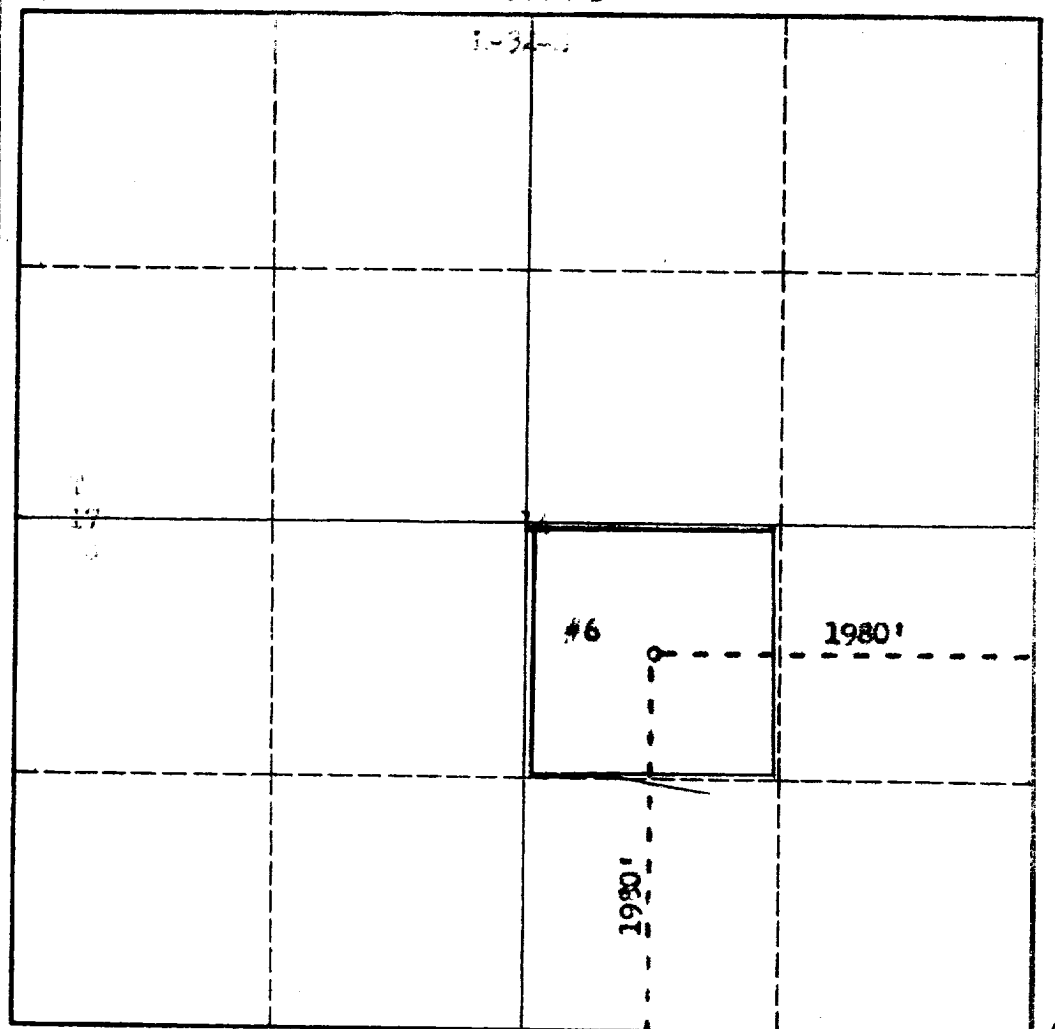
