CONDITIONS OF APPROVAL

- 1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal Leases".
- 2. The Hobbs office (telephone (505) 393-3612) is to be notified in sufficient time for a representative to witness all plugging operations.
- 3. Blowout prevention equipment is required.
- 4. In addition to normal filling of pits and cleanup of location, additional surface restoration work may be required, i.e., ripping of pad and/or access road, reseeding, etc. After plugging the well and before raking final clean-up, you should contact this office unless you have already been advised as to what additional surface restoration work is required.
- 5. If  $5\frac{1}{2}$ " casing is not pulled from below 1000 feet, perforate  $5\frac{1}{2}$ " casing at 1000 feet and squeeze with 100 sacks of cement, leaving 200-foot cement plug inside casing in interval 800 to 1000 feet.
