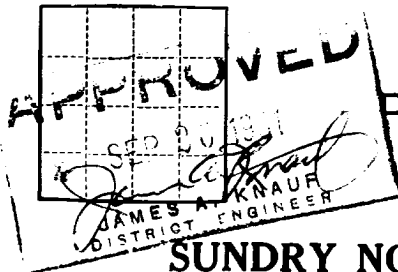

DETAILS OF WORK

It is our intention to drill a well with rotary tools at the above location to a total depth of approximately 1400'. All casing points will be cemented in accordance with approved methods of the U.S.G.S. and any other special requirements will be complied with. It is planned to use the following casing pattern: 11" hole to be drilled, 7 5/8" OD Casing to be set at approximately 750' and cemented with 250 sacks cement to be circulated. 6 7/8" hole to be drilled, 4 1/2" ID casing to be set at approximately 1400' and cemented with 250 sacks. It is calculated that the cement behind the 4 1/2" casing will return to 2500'.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

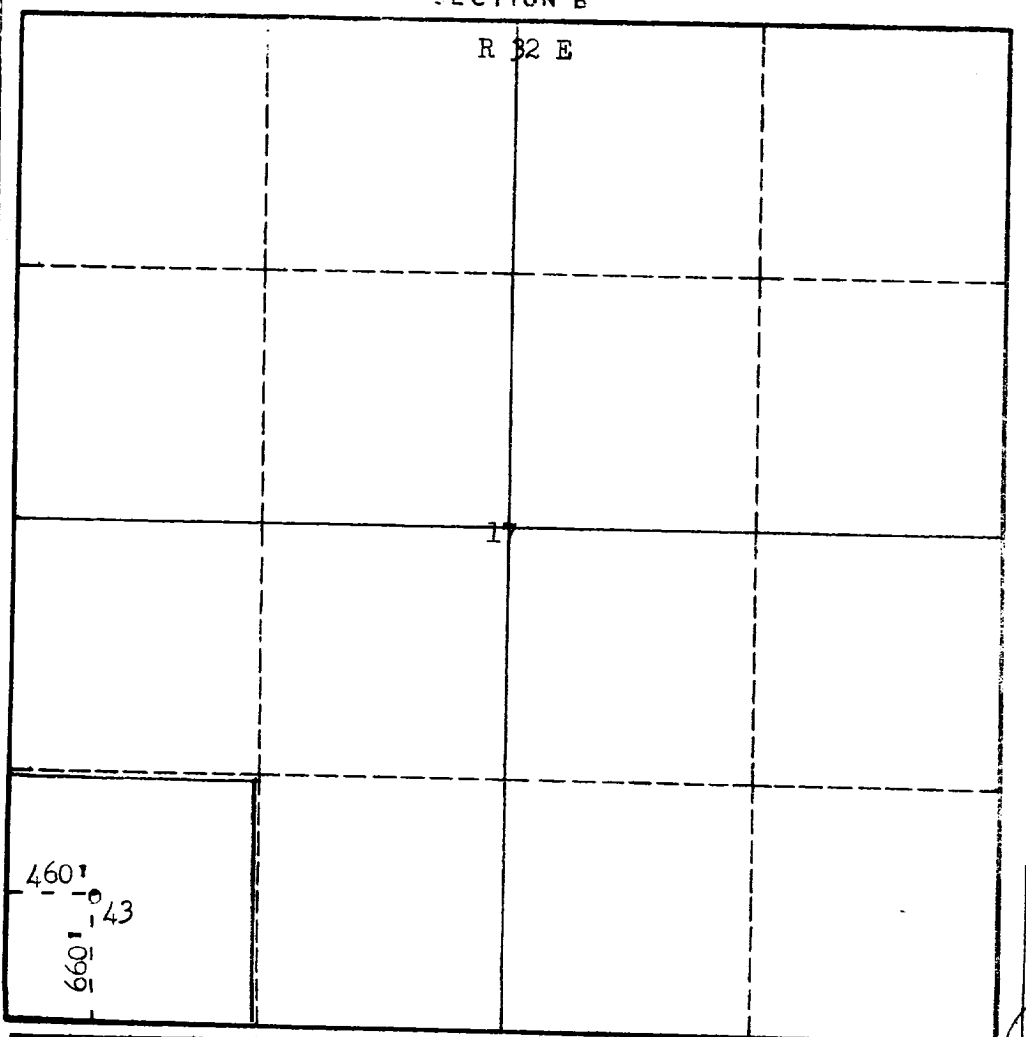
