The following materials were used to install artificial lift equipment on the subject well: 57DA-11.75-42 Bethlehem pumping unit, 7 1/2 HP electric motor and pumping control, 4,070' - 5/8" sucker rods, and 2" x 1 1/4" x 8' x 12' insert pump.

After installation of artificial lift equipment, the well pumped 21 B0, no water, in 24 hours with 23 MCFGPD, GOR 1190. The installation was completed 10-26-60.
