Conoco requests renewal approval of Temporary Abandonment status for the above referenced well. A new, valid MIT was run on 3/23/01 and is attached.

We wish to retain this wellbore for recompletion potential in the Queen, Seven Rivers and Yates formations. The production casing in this well is cemented to surface and the well is in good mechanical condition. Although Conoco does not have current plans to recomplate this well, other wells in the area will be tested later this year and will help quantify this potential.
