This well was converted to a water injection well in conjunction with the MCA Unit Waterflood. 3 5/8" casing is set at 1260' and 7" casing is set at 3913'. 3 3/8" tubing and a production packer were set at 3857' and the well was placed on injection.

The casing was tested to 2,000# PSI for 30 minutes. Tested O. K.

Instructions
