This well was converted to water injections by the following procedures. Verbal approval to convert this well was given by Mr. Gordon on February 17, 1969.

Ran tapered mill in 7" casing from 3836' - 3839'. Cleaned out from 4130' - 4190'. Drilled new 6 1/4" hole from 4190' - 4230'. Ran GR/N & Caliper log. Ran 2" cement lined tubing with packer set at 3799'. Displaced annulus w/ treated water. Placed well on injection. Tested by injecting 410 BW at 0# in 24 hours on 8-25-69
