5. Perforate 4-1/2" casing @ 1,000'.
6. Squeeze 35 sx C cmt w/ 2% CaCl₂ 1,000 - 900' (est. top of salt @ 950'). WOC & TAG
7. Pump 5 sx C cmt 50' to surface.
8. Cut off wellhead and install dryhole marker. Cut off anchors and level location.
