Work started on 4/6/88. MIREU. Run csq scraper. Drillout & jet wash to 4067'. Spot per gravel from 4034' - 4067'. Pickled Hg. Spot 35 bbl 15% HCL - NE-FE acid over shot sections. Spot 60 bbls of resin pack. Spot add'l 41 bbl resin pack. Tag at 3292' & Drillout resin pack to 3866'. WD gravel to 4067'. Run 4" liner to 4061'. Set w/280 sks of 50/50 Poz mix class "C" cement. G/H w/ bit & csq scraper to TOL at 3273'. Clean out & test to 2000 psi. Tie back liner to surface. Set w/160 sks of class "C" cement. Drillout cement from 3141' - 3237'. Drill out float collar to 4062'. Clean out. Run CBZ. Perf 6th zone w/2 jspt from 3726' - 3802'. Perf 7th zone 3852' - 3933' & 9th zone 3992' - 4038'. Run 2 3/8" Hg. Return to injection. Work Completed on 5/17/88.
