Conoco requests permission to perform a Casing Integrity Test on the referenced well in preparation for requesting temporary abandonment approval. The following procedure will be followed:

1. POOH w/production equipment.
2. Set a plug within 100' of the top perf.
3. Notify the OCD 24 hours before pressure testing casing to 500 psi for 30 minutes.
4. RIH w/tubing and circulate packer fluid.
5. POOH w/tubing and fill hole with packer fluid.

When completed, a successful pressure test will be submitted with a reason and a request for temporary abandonment status for this well.
