Openhole: 3,599 – 4,000'; HIC @ 310 - 340' squeezed w/ 50 sx 1/17/95; HIC @ 1,215'  
squeezed 9/25/00

1. MIRU plugging equipment. NU BOP
2. RIH w/ tubing-set CIBP, set CIBP @ 3,550'. Circulate hole w/ plugging mud and pump 25 sx C cmt on CIBP.
3. Pump 35 sx C cmt w/ 2% CaCl<sub>2</sub> @ 2,085' (base of salt @ 1,985'). TAG
4. Pump 35 sx C cmt w/ 2% CaCl<sub>2</sub> @ 955' (top of salt @ 955'). TAG
5. Perforate 7" casing @ 300'.
6. Squeeze 60 sx C cmt under packer 300 – 200'.
7. Pump 10 sx C cmt 50' to surface.
8. Cut off wellhead and install dryhole marker. Cut off anchors and level location.
