Drilled to 315', set 8-5/8", 8Rd 32#, at 302'. Cemented with 150 sacks. Cement circulated. WOC 24 hours, tested for water shut off at 600 pounds for 30 minutes. No decline in pressure observed. Drilled to TD of 3633 and set 5 1/2", 14 and 15.50#, at 3632'. Cemented with 150 sacks. WOC 48 hours. Tested casing at 1000# for 30 minutes, with no decline in pressure.
