This was re-entry of an old well - Top of 10" casing was found in the bottom of the cellar at 8'. Well cleaned out to 2500' inside of 5 1/2" O.D. casing. 4 1/2" EUE 12.60# tubing ran for casing in top of 5 1/2" casing. Cemented with 100 sacks of cement April 1, 1968. Let set 48 hours - Drilled out and found cement job O.K. Cleaned out to 4025' and ran tubing and rods to 3950' to put well on production.
