Propose to set bridge plug at 3950' with 35' cement on top of bridge plug. Cut off oil string at free point. Set 35 sacks cement plug at cut off point or 25 sacks cement plug at 2900'. If casing cutt off point is above that depth, set 35 sacks cement plug at bottom of surface, cut off surface at firepoint, Set 300' cement plug at surface with heavy mud between all plugs/ Set dry hole marker and clean up location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
