4247' - Total Depth - Line. Run Temperature Survey - Top of cement on outside of 7-5/8" casing at 1631', ratio of actual to calculated fill 41.1%. Checked top of cement at 4106'. Tested casing & connections with 1000# for 1/2 hour - no pressure drop. Drilled cement from 4106' to 4207' & tested casing & connections with 1050# for 1/2 hour - no pressure drop. Started drilling formation and 6-3/4" hole at 9:35 A.M., 10-29-50.
