Tested casing & connections with 1000# for 1/2 hour - no pressure drop. Drilled cement from 4138' to 4225' & tested casing & connections with 1000# for 1/2 hour - no pressure drop. Started drilling formation and 7-7/8" hole at 8:00 P.M., 4-30-51.
