DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

9913' DOD - Pulled 2-3/8" OD Tubing & perforated 5 1/2" OD Casing from 9778' - 9796' & from 9817' - 9848' w/ 4 bullets per foot. Ran tubing w/ straddle packers and acidized each of above perforations with 500 gals. 15% IST Acid. Re-ran tubing with flow valves & put well on production.

On test of 8-18-54, well flowed 333 bbls oil, 8 bbls water in 24 hrs on 18/64" choke, TP-850#.
