3100' - Total Depth - Lime & Anhydrite. Ran Temperature Survey - Top of cement on outside of 8-5/8" casing at 1745', ratio of actual to calculated fill 49.5%. Checked top of cement at 3024'. Tested casing & connections with 1000# for 1/2 hour - no pressure drop. Drilled cement from 3024' to 3100' & tested casing & connections with 1000# for 1/2 hour - no pressure drop. Started drilling formation and 7-5/8" hole at 10:15 A.M., 1-13-51.
