1004.0' DCD - Pulled 2-3/8" OD Tubing & perforated 5 1/2" OD Casing from 9805' - 9820' & 9876' - 9885' & 9920' - 9935' w/ 1/4 bullets per foot. Re-ran tubing w/ straddle packers and acidized each of above perforations w/ 500 gals. 15% LST Acid. Total 1500 gallons acid. Re-ran tubing w/ flow valves & put well on production. On Test of 12-7-52, Well flowed 52.99 bbls oil, 13.25 bbls water in 2 1/2 hrs. on 1 1/2" choke w/ 650# Input gas. TP-70#.
